Disciplinary proceedings, challenging the decisions of sport regulatory bodies; breach of confidentiality and breach of privacy including urgent injunctive relief.

PROPERTY: Property litigation, Mortgages and Charges, Equitable interests. Carly has also assisted in cases concerning large scale corporate fraud, breach of directors' duties, section 459 petitions, applications to the Supreme Court of the Seychelles, and assisted in the reported case of In the Matter of Lune Metal Products Ltd (in Administration) [2006] EWCA Civ 1720. Carly also recently represented an international football agent in the matter of Re a Debtor - a dispute between an international football agent and a premiership footballer as to the entitlement of fees on transfer.
