Practice Overview

Chris has recently been appointed to the prestigious Attorney General's Regional C Panel (from March 2023 onwards).

Recent multi-track instructions include the following (updated in December 2023):

- An ongoing case involving a serious injury to the spine, with the final claim likely to be pleaded in excess of £500,000;
- An ongoing case involving disabling physical and psychological injuries, with an almost complete loss of ability to work.

Cases

November/December 2023: Chris represented a government agency in an inquest following a death in a prison. The scope of the inquest was broadened by the finding of the Coroner that Article 2 of the ECHR had been engaged. The inquest also involved a jury.

November 2023: Chris successfully represented a refugee who had been badly burned in an accident at work. The Defendant alleged that the Claimant had been lying about the extent of her injuries. Chris proved that the Claimant was telling the truth, and recovered a total of £41,686 in damages for the Claimant. Chris also defeated an application for a wasted costs order against her solicitors.

July 2023: Chris successfully represented a Claimant who pursued a high-value claim for credit hire following an accident where their vehicle had been damaged. After a one-day hearing in Lancaster County Court, the Claimant was awarded over £50,000 for their damages and costs.

July 2023: Chris represented a government agency in their application to rely upon a witness summary as part of a long-running case in the High Court. Chris prepared a detailed skeleton argument, and attended a hearing in the Royal Courts of Justice. The Court agreed with Chris that the Defendant should have permission to rely upon their witness summary.

June/July 2023: Chris represented a medical expert who had been accused of negligently preparing a medical report. The Defendant sought a wasted costs order against the medical expert. Chris defeated the application and obtained an order for the Defendant to pay the medical expert's costs.

December 2022: Chris successfully represented a retired police officer who suffered a serious burn injury after an accident at a hotel. After a one-day trial in Hull County Court, Chris successfully proved that the tour operator was to blame, and the Claimant was awarded almost £20,000 for their damages and costs.

August 2022: Chris successfully represented a veterinarian who was badly injured after falling into a manhole. The Defendant agreed to settle the claim before trial and pay the Claimant £30,500 on account of his damages.

May 2022: Chris successfully represented a lady who was injured after a slipping accident at a supermarket. The Defendant agreed to settle the case and pay the Claimant £80,000 on account of her damages.

March 2022: Chris successfully represented an electrician who made a high-value claim after being injured in an accident at work. The claim was complex and involved difficult issues of vicarious liability. With careful preparation of the case from Chris and his experienced solicitors, the Defendant agreed to settle the case and pay the Claimant over £100,000 for his damages and costs.
