Cases

In the Matter of MW (Stockport Coroner's Court 2019) Acted on behalf of the manager of a care home in 4-day hearing concerning the care and referral of a resident.

In the Matter of FR (Heywood Coroner's Court 2019) Acted for a company providing housing to individuals who are homeless or who are at risk of homelessness. Hearing concerned death of a male who was a resident in supported accommodation.
