## <u>Week 17</u>

I spent Monday to Wednesday studying for the BSB Professional Ethics assessment. On Thursday my knowledge and application of ethics were tested. Twelve in depth questions were asked in three hours. Time management dictated that each question needed to be answered in 15 minutes or less. It was an intense assessment of speed, accuracy, knowledge, and application. Candidates were permitted to refer to the BSB Handbook during the assessment. Therefore, one needed to be very familiar with the Handbook's content and its online navigation. On Friday I shadowed second six pupil Imogen Nichol in a small claims trial in Barnsley. This claim arose due to a road traffic collision. Imogen represented the Claimant. There were a few lessons that were deduced:

- While conducting a conference with the Claimant, it is helpful to show the Claimant the location of the collision on Google Maps. This provides the Claimant with an opportunity to explain their version of events while referring to an image of the location. It is also a helpful opportunity for the Claimant to explain why they disagree with the Defendant's version of events.
- If Counsel receives different instructions from the lay client in comparison to the professional client, Counsel must follow the lay client's instructions. In this case, the Defendant's insured (who was supposed to give evidence) was gravely ill and could not attend court. The instructing solicitor instructed Counsel to agree to an adjournment with the Defendant's representative. However, the Claimant instructed Counsel to proceed with the trial. Ultimately, Imogen followed her lay client's instructions and proceeded with the trial. Imogen provided excellent client care by updating the instructing solicitor about the Claimant's position.
- When determining whether an adjournment should be granted, the Judge decided that the trial should proceed. The Judge explained that it was evident that the Defendant's insured would never be in a position to stand trial due to the severity of the illness.
